Methodology

- Online random sample survey of adult California residents
 - Links to web survey sent via text and email
- Offered in English and Spanish
- Conducted by EMC Research from February 12 23, 2025
- 1,000 total interviews completed:
 - 700 interviews statewide; overall margin of error ±3.1 percentage points
 - 300 interview oversample in the nine Specific Interest Counties, resulting in 359 total interviews in these counties; margin of error ±5.17 percentage points
 - Specific Interest counties defined as those with the highest incidence of gun suicides, homicides, and domestic violence gun homicides per capita
 - · Amador, Del Norte, Fresno, Inyo, Kern, Lake, Lassen, San Joaquin, and Siskiyou Counties
 - Specific Interest Counties weighted down to actual proportion of state population


Baseline Survey Highlights


- Most Californians (70%) believe California does have laws that allow for the temporary removal of guns from someone deemed a threat, but just 24% say they know a lot about any of the 9 types of Protection Orders listed.
- Few have heard much recently about Protection Orders (30% heard anything, 9% heard a lot), and just 8% have visited the website GunSafety.CA.gov
- Specific awareness of the features and benefits of Protection Orders is limited, and 79% say they are concerned about their lack of information about how the orders work.
- Three-quarters of Californians (77%) say they would consider filing a Protection Order to remove access to guns if they felt someone was a threat, but concern is high about retaliation, lack of a requirement for treatment before gun access is restored, and uncertainty about ability to determine if the threat is enough to require action.
 - Just 33% strongly agree that they are confident they would be able to recognize the signs of someone being a threat to themselves or others.



Depth of Knowledge: Specific Laws

Just a quarter of residents feel that they know a lot about any of the Protective or Restraining orders, with DVROs being most familiar.








Protection Order Attributes: Who Can File

Protection Order Use Likelihood

Over three-quarters of residents statewide say they would be likely to seek out a Protection Order if circumstances called for it, with just under half saying they're very likely to do so. That number is slightly lower in Specific Interest counties.
